Box 1

I. Personal Papers, 1842-1976

The A.P. Meharry - Martha McMillin Correspondence is mostly personal, although there are occasional references to social, religious and cultural affairs. The letters relate to Martha's outlook on life and marriage, and several letters contain comments on loneliness.

The C.L. Meharry Correspondence relates primarily to university campus life and activities including professors, classes, sports, social events, organizations, and fraternity and sorority affairs. The correspondence presents a useful picture of university life and the lives of college students at the University of Illinois (C.L. Meharry) and at Purdue University (Clara Esther Burghardt). Other topics discussed are Clara Esther Burghardt's beginning work as a teacher, the sickness and death of A.P. Meharry, family affairs, and personal matters. One letter contains a description of an operation in the Meharry family home with which C.L. Meharry assisted.

Personal Financial Papers and Records include checks, receipts, and financial statements for the Meharry family.

Also included in the series are three speeches written by C.L. Meharry. Two of the speeches were possibly written for the Fourth of July, covering topics such as the values of the United States, the flag, and those who sacrificed their lives for the nation. The third speech discusses United States politics, warning against corruption and political radicals.

The Attica School Board Minutes and Agreements document discussions regarding the Board of Finance for the School City of Attica, Indiana. Board members discuss the issues of nominations to the Board, bonds, and other financial matters. C.L. Meharry served as Secretary.

Miscellaneous Family Papers include personal materials such as invitations, notebooks, and college keepsakes from University of Illinois, Purdue University, and Walden University. These keepsakes include graduation invitations and programs, a scrapbook, and an acceptance letter.

Obituaries and Estate Papers contain agreements, accounts, appraisals, correspondence, and other materials relating to the estates of the Meharry family. Also included are obituaries for Meharry family members.
